Description

Nu Zone W sealer stripper is a fast-acting concentrated stripper. Nu Zone W removes water-based sealers and wax, contains no ammonia solvents or phosphates and is non-corrosive. It can also be used as a powerful degreaser. It is recommended for cleaning unsealed calcareous stones and marble.

For prolonged use, gloves are recommended.

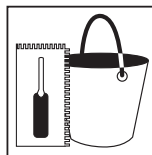
Main use

For residential and light commercial uses, both indoors and outdoors. Recommended for calcareous stones or unsealed marble. Easily strips acrylic finishes and built up coats of wax.

Instructions

Application

Test on a small surface first to ensure suitability of coverings.



Dilute 1 part Nu Zone W into 1 to 3 parts hot water. Spread with a cloth while wearing gloves. Strip small areas at a time. Let product act 2 to 5 minutes. Never allow the product to dry on the surface. Use a low speed stripping machine (175 RPM). Remove all remaining residues using a wet surface vacuum cleaner. Rinse thoroughly with water and allow to dry completely before applying sealer.

Limitations

- Keep out of reach of children
- Wear safety glasses and gloves when applying
- Use in a well-ventilated area
- Avoid freezing
- Do not use on composite stone
- Varnished wood, plywood and MDF wood fibre mouldings should be protected
